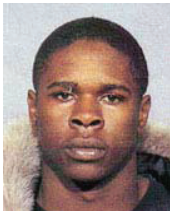

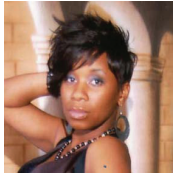

Terri's body was discovered at N5900 W9950 in the City of Milwaukee, WI, in a wooded area near railroad tracks. Terri had been sexually assaulted and died as a result of numerous stab wounds. The area where Terri was found was behind the old "Moreway" store located at 10100 W. Appleton Avenue.
